

The Central Winds Pickleball and All Things Pickleball — General Policy and Release of Liability Waiver: Services, Payment, Travel, Medical, and Video

PLEASE READ CAREFULLY. THIS IS A LEGALLY BINDING AGREEMENT.

By signing below, I (the “Participant”) agree to the following terms and conditions in connection with my participation in the group trip to the Club Med in Turks and Caicos from October 1st to 5th, 2026, organized by Everything Racket Sports LLC (AKA. Central Winds Pickleball) and All Things Pickleball LLC its employees, instructors, any independent contractors or subcontractors, and the transportation and lodging services who will all herein be simply referred to as “the Provider.”

1. SERVICES PROVIDED

The Provider will arrange and coordinate:

- Accommodations at Club Med in Turks and Caicos
- Round-trip ground transportation between Providenciales International Airport (PLS) and Club Med in Turks and Caicos
- Welcome dinner with the coaches
- 5.5 - 6 hours of pickleball clinic and instruction (1:5 ratio max)
- “Challenge Court” with the coaches
- Organized play sessions (separated by skill)
- Unlimited open play
- Selkirk Giveaway & farewell dinner with the coaches

All other travel components, including but not limited to airfare, travel insurance, excursions outside the package, and personal expenses, are the Participant's sole responsibility.

2. PAYMENT TERMS

Payment Policy

An initial deposit of \$800 per Participant is required to secure the Participant on the trip. By July 1st, 2026, the remainder of the cost is required. Failure to pay in full by the deadline may result in the cancellation of the Participant’s reservation without a refund.

Cancellation & Refund Policy

- 121 days or more from the date of trip: 50% refund of the initial deposit
- 91 - 120 days from date of trip: Loss of initial deposit
- 61 - 90 days from date of trip: 50% refund of the total amount paid
- 60 days or fewer days from the date of the trip: No refund

If you've paid and need to withdraw after the deadline, you can instead find a substitute to take your place. The Provider is not responsible for any losses due to cancellations, flight delays, missed connections, or any acts of the universe.

3. TRAVEL, DOCUMENTS, AND INSURANCE

I, the Participant, am solely responsible for purchasing, securing, and maintaining an airline flight, a valid passport, and any necessary visas or documentation required for travel to Turks and Caicos. I acknowledge that I have been strongly advised to purchase comprehensive travel insurance, including coverage for baggage loss.

4. MEDICAL AUTHORIZATION

In the event of a medical emergency, the Participant authorizes the Provider or its representatives to secure treatment deemed necessary for my health and safety, and the Participant agrees to assume full financial responsibility for such care as specified in The Central Winds and All Things Pickleball: Waiver and Release Liability Waiver. I, the Participant, acknowledge that I have been strongly advised to purchase comprehensive travel insurance, including coverage for medical emergencies.

5. PHOTO/VIDEO RELEASE

I, the Participant, grant permission to use photos or videos taken during the trip that may include my image for marketing or promotional purposes, unless I explicitly opt out in writing before the trip.

6. GOVERNING LAW

This waiver shall be governed by and construed in accordance with the laws of the state in which the Provider is registered.
